

## ANNEXE B

### Information to be provided in advance by vessels requesting permission to carry out transshipment operations in Papeete's port, in French territorial waters or in Polynesian EEZ

The only port authorized for transshipment operations is Papeete. This document must be transmitted 96h before arrival at the dock or at the latest 6h before entry into the Polynesian EEZ.

For transshipment operations at sea (French territorial waters or Polynesian EEZ), this document must be transmitted 76h before the scheduled start of operations.

**As of october 5, 2017** (French Polynesia Environment Code, art LP2211-3), all species of shark are protected under local law. Thus, the following are prohibited for all species of shark:

- fishing, mutilation, and
- whether alive or dead, transport, use, possession, offering for sale, sale or purchase, import or export.

Any breach of this article's provisions is punishable by two year's imprisonment and a fine of 17.800.000 CFP (~150.000€).
